The 1st Annual Homesteader Color Run is a one of a kind experience about participants of all different speeds, ages, shapes running or walking the cross country course around the Montana State University Southern Agriculture Research Center and being blitzed in all different colors. Participants can enjoy Homesteader Days festivities after the race which includes Mama’s Wranglers aka Kid Fiddlers at 7:00 p.m. on the main stage and fireworks at dusk.

SIMPLE rules. 1. **White shirts** (any mostly white T will work great) if going through the color zone. The **Color Zone** will consist of volunteers blitzing the participants with different colors. Participants not wishing to be covered in colors can take the no color zone.
